During 2007-08, the Government of Sindh reaffirmed its commitment to public private partnerships and community participation for education by funding the Rural Based Community Schools (RBCS) Project, SEF's community based education intervention.

The project is a natural extension of the organization's community based schooling initiatives and brings together the resources and development efforts of the public, community and private sectors. The program aims to provide access to quality education for out-of-school children so they can achieve primary level competencies as per the National Curriculum in 3 years through an accelerated syllabus.

**SEF intends to engage the services of the reputable organizations/companies which have expertise/capabilities of printing large quantity of exam papers/material in very short and limited time period. Companies that have expertise/capabilities of 5 years in their field along with the turnover of Rs.10 million per annum and must have registered in all tax departments (FBR & SRB) may participate.**
