The Government of Sindh has received a loan from the World Bank for Reconstruction and Development towards the cost of Sindh Education Reform Program(SERP-II), and it intends to apply part of the proceeds of this loan to payments under the contract for Public Private Partnership in Education "PPRS".

The Sindh Education Foundation with support from World Bank and the Government of Sindh is embarking on an initiative for improving access to quality education through cost-effective private schooling model. Under this invite, in 1st phase 200, in 2nd phase 100, 3rd phase 185 schools & 4th phase undertook last year with 320 PPRS schools have been established through private entrepreneurs selected via an objective merit-based and transparent selection process in 18 districts 1-Khairpur, 2-Larkana, 3-Qamber-Shahdadt, 4-Dadu, 5-Shaheed Benazirabad, 6-Sanghar, 7-Badin, 8-Thatta, 9-Umerkot, 10-Mithi at Therparkar, 11-Ghotki, 12-Jacobabad, 13-Jamshro, 14-Kashmore, 15- Malir Karachi, 16-Shikarpur, 17-Sujawal and 18-Mirpurkhas, of Sindh Province through the program "Promoting Private Schooling in rural Sindh" (PPRS).

One of the key components of this project is to provide Quality Education and to ensure this students' assessment mechanism has been introduced by the SEF. This mechanism will not only ensure the quality of education but also entitle qualified schools to continue getting subsidy from the Government on per child basis.
