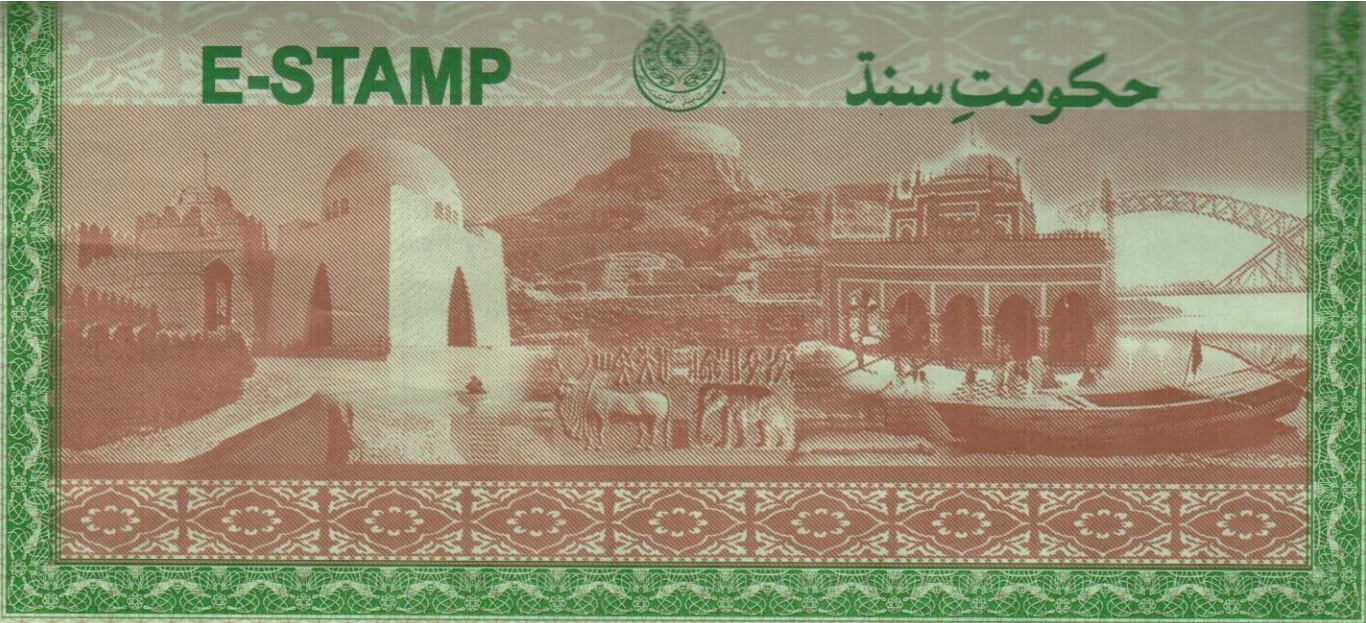

## Contract

THIS AGREEMENT was made on the day 30<sup>th</sup> of October 2025 between **Sindh Education Foundation (SEF) (First Floor NICL Building, Survey No. 183/4, Abbasi Shaheed Road, Cantonment Karachi, Sindh, Pakistan)**, (hereinafter called "the Procuring agency (P.A)") of the one part and **M/s. Adamjee Insurance Company, Adamjee House, I.I. Chundrigar Road, Karachi - 74000** (hereinafter called "the Service provider") of the other part:

WHEREAS the Procuring agency invited bids for the services of **HIRING OF GROUP HEALTH INSURANCE COMPANY FOR SEF EMPLOYEES AND THEIR DEPENDENTS, TENDER REF. # SEF/NP/25-26/03** and has accepted a bid submitted by the Service Provider for the services in the sum of **Rs. 242,506,298/- (Two Hundred Forty-Two Million Five Hundred Six Thousand Two Hundred Ninety-Eight Only)** (hereinafter called "the Contract Price"). The Contract period shall be initiated from **01<sup>st</sup> November 2025 to 31<sup>st</sup> October 2026** and will be awarded for the initial first year of the tender and may extended on an annual basis for the next two years subject to the satisfactory performance and availability of funds.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS: ✓

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be treated as integral part of this contract and all obligation and compensation provided thereunder, shall be binding on the Service provider.

- (a) The Bid Form and the Price Schedule submitted by the Bidder; (**Annex-1**)
- (b) The Schedule of Requirements; (**Annex-2**)
- (c) The Technical Specifications (TORS); (**Annex-3**)
- (d) The General Conditions of Contract; (**Annex-4**)
- (e) The Special Conditions of Contract; (**Annex-5**)
- (f) The Procuring agency's Notification of Award. (**Annex-6**)

3. In consideration of the payments to be made by the Procuring agency to the Service provider as hereinafter mentioned, the Service Provider hereby covenants with the Procuring agency to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

#### 3.1 Coordinator:

The P.A designates, **Deputy Director Human Resource Department** Procuring Agency's Coordinator shall be responsible for the coordination of activities under the Contract, for receiving/ endorsing/ verifying the invoices for payment, and for acceptance of the deliverables by the Service Provider. ✓

The coordinator shall submit the progress report/ completion report at the time of payment.

#### 4. Resolution of Disputes:


- a). Any issues rise related to medical bills, that shall be resolved amicably and with the mutual consent.
- b). Any dispute arises may be resolved by the parties amicably with out getting into any litigation and in any court of law.
- c). The extension of agreement/ contract may be extended on the basis of mutual consents for the next remaining years.

The Procuring agency hereby covenants to pay the Service Provider in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
